What's New for the Summer of 2024:

- Broader usage of Frontline allows subs to see open positions and pick them up in advance (Thank you, Missy, in Human Resources).
- Great turnout of returning teachers and support staff to work summer school. Once again, there is no need to hire staff outside of the Sheboygan Area School District.
- Almost all staffing positions are filled!
- The Jackson Elementary site will be run out of Wilson Elementary this summer due to some needed maintenance projects at Jackson Elementary.

- **All district elementary and middle school ID (Intellectual Disability) programming will run out of Horace Mann Middle School, including the elementary Sparks (Students Practicing Academics, Responsibility and Kindness) program. Allowing, us to utilize special education staff based on the needs of the students and their attendance each day.**
- **We have several new lead teachers at the elementary level (Cooper and PR).**
- **Rich Gullixon, who coordinates our elementary curriculum and teacher placement, announced that this will be his last summer. THANK YOU Rich for all you've done for our summer school program! Katherine Brooks, from Sheridan, will work with Rich this summer and take over next summer. Welcome to the team Katie!**
- **The summer school booklet is entirely electronic again this year, allowing families easy access to the information.**
- **Registration will open right after Spring Break and will be completed via Skyward. Building secretaries are trained to help the parents who need assistance.**
- **We offer High School Credit Recovery, Jailbound, 100 + Enrichment Classes, Middle School Reading and Math, and Elementary School Reading and Math.**
- **Updates on enrichment courses:**
 - New Hmong language classes and Sign language classes at the elementary level.
 - Scaled down the sites so there aren't as many locations running in the afternoons and can get more students to those sites. The sites will coincide with the academic locations so a child could stay after academics have lunch, and then continue with enrichment courses. (This will be great for working parents). Enrichment courses will run from 12-2 and 2-4.
- **Updated the Sheboygan Area School District Staff Summer School Handbook to be consistent with the handbook used during the school year (Thank you to Jami and Bo in Human Resources).**
- **Breakfast and lunch are provided free at all sites with on-site eating.**
- **Boys and Girls Club continues to offer child care at Longfellow along with busing to and from the sites.**

Early Literacy Curriculum Council (ELCC)

Early Literacy (K-3) Curricula and Instructional Materials

- DPI and the Early Literacy Council have each shared a list to be approved by the Joint Finance Committee (final decision from JFC by March 8, 2024)
 - SASD established a representative team to begin our process in October 2023
 - Completed an analysis of our needs
 - Reviewed the resources being used to evaluate programs by the Early Literacy Council
 - Conducted an initial review of the recommendations from DPI
 - Reviewing samples of materials



Teacher Preparation and Instruction to Teach Reading Budget Implications

- Mandatory professional development for teachers in grades K-3, elementary school principals, and reading specialists must begin **by July 1, 2025**
 - Districts are required to pay for the training
 - Title funds are not allowed to be used for state mandated training
 - All training through CESA 6,8,9 will be allowed for Principals and anyone who completed a training prior July 1, 2024
 - All training after July 1, 2024 will come from the Center for Effective Reading Instruction's approved list



Teacher Preparation and Instruction to Teach Reading Budget Implications

- SASD established a leadership team from each building to participate in the Impactful Literacy Academy for the 2023-24 school year
 - All Principals will be trained by fall of 2024 through this training
 - All members of the Building Literacy Leadership Teams will meet the training requirements by March 12, 2024
 - All interventionists have completed an approved training that is specific to the interventions they are providing
 - A plan for training the remainder of the K-5 classroom teachers, Multilingual Learner teachers, and Special Education teachers will be determined in April 2024



Reading Readiness- Early Literacy Assessment

- 4K-3rd grade Reading Assessment
 - Amendment was sent to Senate to delay the first administration of the Universal Assessment (February 26, 2024):
 - Beginning in **January 2025**, required to screen all 4K students **once** and all 5K - 3rd grade students **two** times in the 2024-2025 school year using a universal screening assessment selected by DPI
 - SASD will wait for announcement of the assessment in late spring 2024
 - Announcement determines our plan for training and assessment in grades 4-5
