We hired 3 Interns which are paid Student Teachers (1 for Family and Consumer Ed and 2 Special Education) for 2 <sup>nd</sup> semester as a recruitment tool for next year hires. Established relationships with UW-Stevens Point and UW-Stout related to our Family and Consumer opening Fall, 2018. Established relationship with UW-Whitewater for Special Ed interns.	June 30,2018	
2	Explore and potentially develop a student loan program for SASD education undergraduate students with a retention component connected to the loan	6/27/17 Spoke to Manitowoc regarding the Administration of their student loan program. Next step, find a financial institution willing to administer the program. Exploring what other school districts are doing to "grow their own" teachers. Spoke to Verona regarding their Minority Teacher initiative with current staff and students. Verona has invested hundreds of thousands of dollars. I have joined the Education Career Pathway group. We are exploring Educators Rising (national student group) as a Co-curricular option as a means to get more students interested in Education. Spoke to SPEF regarding running the student loan program through them since SASD is not able to use public funds for loans. SPEF declined. We will need to explore other routes to grow our candidate pull outside of a loan program. 2/26/18 met with Brian Frink, Lakeland Education Dean. SASD is exploring a Cooperative Education partnership with Lakeland for Education students.	June 30, 2018
