FREE TRANSPORTATION PROCESS

All Transfer Requests are approved with the understanding that transportation is the parents'/guardian's responsibility. However, from time to time some of the district's buses have available space. In these situations, the school district would be able to provide free transportation for your child. Approval of Free Transportation Applications would be on a year-to-year basis and would have to comply with the conditions set forth below.

- 1. Free Transportation Applications will be accepted at any time during the school year. The Student Transportation Department will require three weeks to process your request. Parents/guardians will receive a written response to their request.
- 2. Requests for free transportation will only be approved if there is **no additional cost** to the Sheboygan Area School District.

The following criteria will apply:

- a. The district will not re-route a bus to accommodate the request.
- b. Only existing bus stops will be used.
- c. Space availability will be determined by assigned ridership for programs/schools.
- 3. During the course of a school year if the bus my child has been assigned to becomes filled beyond capacity of the bus, my child will no longer receive free transportation and parents/guardians will receive three weeks advance written notification of that fact.
- 4. All applications received in the Student Transportation Office will be considered for approval. Applications will be processed on a first come, first serve basis.
- 5. Free Transportation Applications are required each school year.
