  - i. Review & Approve Financials
    - 1. Balanced out September.
    - Two emergency spends: (1) on Nov. 11 our monument sign was hit by a car. (2) Rooftop Unit #3 failed inspection and needs immediate replacement. These costs will restrict future spending.
    - 3. Draft of Charter Budget is due to SASD January 31, 2025. Final due in June.
