I further understand that all vehicles parked on school property are subject to periodic external inspection using dogs, trained to detect the presence of illegal drugs and other unlawful items. Please return this form to the School's Activity Office with the \$30 annual fee, cash or check only. Payment must be made prior to a Parking Sticker being issued. Students with delinquent fines or attendance problems may be considered last for parking permits or may have permits revoked if corrections are not made. Only ONE sticker will be issued to a student at a time. Students who change vehicles need to remove the sticker from the current vehicle and bring it to the Activity's Office so that appropriate forms can be filled out. If you do not you can be subject to receiving a parking ticket. There are no one-day passes if your vehicle is being serviced. High School Parking Regulations

Each high school provides limited parking for faculty, students, and visitors by permit only. Parking spaces are assigned on a priority basis with students with special needs given first priority followed by seniors and then juniors. Sophomores may be issued parking permits in some circumstances if there is space available.

Students with delinquent fines or attendance problems may be considered last for parking permits or may have permits revoked if corrections are not made.

Students who drive vehicles registered to their parents or another registered owner must have the registered owner of the vehicle complete the attached parking application form. This signed form must be returned with the \$30.00 annual fee (cash or check only) to the School's Activity's Office to receive a parking permit.

The parking sticker must be affixed to the rear window (opposite the dashboard), in the lower left hand corner. Lost stickers will **NOT** be replaced.

Additional Reminders

- Safety is a real concern for our student drivers, students in general, and our community at large. Caution needs to be exercised by our drivers before school, during the noon hour, and after school.
- Parking is restricted to cars with permits from 7:00 a.m. 4:00 p.m.
- Parking is allowed only in marked stalls, between the lines.
- Students are prohibited from parking in the staff and visitor's stalls.
- Parking in the fire lanes is prohibited.
- Only ONE parking sticker is issued. There are no replacements.
- Violators will be ticketed by the Sheboygan Police Department and will forfeit their sticker and future parking lot privileges.
