## ***SEVEN SCHOLARSHIP AWARDS AVAILABLE***

The Sheboygan Area UAW CAP Council is sponsoring six (6) \$700 scholarship awards to be presented to eligible graduating high school students to assist them in the continuation of education at any accredited university, college, or trade school.

The Sheboygan Area UAW CAP Council is sponsoring one (1) \$700 scholarship award to be presented to currently enrolled UW Green Bay - Sheboygan students.

### **ELIGIBILITY REQUIREMENTS**

Eligibility for these scholarship awards is limited to any son, daughter, or legal dependent of a parent who has been a member of the UAW for a period of at least one (1) year preceding the issuance of the awards, and is a current member of any UAW local union affiliated with the Sheboygan Area UAW Community Action Program Council.
